Summer School Credit Recovery 2024 Registration Instructions for Students Attending a Durham Catholic Secondary School

1. Students are to fill out the attached Summer School course selection form with the assistance and approval of their home school Guidance Counsellor.
2. Completed forms must be signed by a student's parent or guardian and returned to Guidance for processing and enrollment. **You will not be registered until you return this form to your Guidance Counsellor.** Guidance staff will then cross-enrol student into course selection.
3. Students who have not registered before June 28 will not be allowed to attend summer school without their school's approval. **Guidance Counsellor approval is mandatory.**

In order to take a credit recovery course, students must have taken the same course and level within the previous two school years prior to summer school and have achieved a mark of less than 50% (but not lower than 35%) to be eligible for a credit recovery course. Students who previously passed a course but wish to upgrade their mark may also register for the two week credit recovery course.

- There are no activity fees for summer courses.
- Students may register for one credit recovery course in each semester. A student cannot combine an accelerated high school credit course with a credit recovery course since the weeks overlap.
- Students will be expected to adhere to the standard rules of Academic Integrity and follow the Code of Conduct.
- Students must attend class each day in-person starting at 8:30 a.m. and must be present for all assessments. Students may leave after 10:30 a.m. and work from home with a signed letter of parental permission. Students are expected to meet all deadlines.

Students will be notified by email if courses are cancelled, but please check our website www.con-ed.ca for complete course updates. All course updates will be finalized by Friday, June 28.
